

KORG USA VOX MV50 Contest

Official Rules

NO PURCHASE NECESSARY. The **VOX MV50 CONTEST** (“Promotion”) takes place beginning at 12:00PM EST, April 24th, 2017 and ends at 11:59 PM EST, May 26th, 2017 (the “Promotion Period”). The Promotion is sponsored by Korg USA, Inc., 316 South Service Road, Melville, NY 11747 (“Sponsor”). All federal, state and local laws apply. Void where prohibited.

Eligibility: The Promotion is open to all residents of the 50 United States and Washington D.C. who are at least 18 years old, have reached the age of majority in their state of residence, and who have internet access at the time of the Promotion Period.
